### 2021 Projects

• Upcoming August film series event: Moderator options and panel makeup were discussed for a limited attendance panel discussion on August 25 of a documentary on conservative columnist Thomas Sowell.at the Community Center in Buena Vista, Colorado. Notification of the police and covid risk notice to attendees were discuss. The board authorized the president to arrange for details and cover expenses of the event.

• **Upcoming October film series event:** JoAnne Allen led a presentation of a film presentation and panel discussion of the Netflix film *The Social Dilemma* to be held at the Salida Steam Plant on October 21, 2021.

• **Funding of Events:** Jan Wondra offered free advertising of the events in the form of an in-kind contribution from Ark Valley Voice, which she estimated as worth approximately \$50/week. The possibility of co-sponsorship with the Colorado Mountain College was discussed as well as the use of ticket sales to the October event. [Jan Wondra left the meeting at this point.]

#### The THAVF Website

Discussion of the desirability of adding pictures to the website and posting or linking to the video of the county commissioners candidate forum held in October of 2020. Also discussed were the desirability of improvement in the News and Programs pages and the Home page.
